It is a condition to the Participant being accepted into a Mana Skateboarding lesson/event/competition that the following points be read and acknowledged by clicking submit form below.

## RISK WARNING AND EXCLUSION OF LEGAL LIABILITY.

Mana Skateboarding makes safety its first priority while enjoying the fun and healthy sport of skateboarding however, there are risks involved in skateboarding as with any other sport. During a Mana skateboarding lesson/event/competition, participants must wear a helmet. This form must be submitted by the Participant or a Parent/Guardian if the Participant is under 18 years of age, prior to his/her commencing activities with Mana Skateboarding and prior to he/she being entitled to participate in lessons/events/competitions with Mana Skateboarding.

Please read carefully the following acknowledgements and assumptions of risk relating to activities provided by Mana Skateboarding:

The Participant warrants that he/she is fully medically fit to undertake the lesson/event/competition.

The Participant agrees that he/she will participate in the lesson/event/competition entirely at his/her own risk.

The Participant acknowledges that the lesson/event/competition carries some risks and/or dangers including physical injury that may result in permanent disability or death, and economic loss or damage.

The Participant agrees to fully comply with all directions given by the Mana Skateboarding coaches and officials.

By participating in skating lesson/event/competition with Mana Skateboarding and/or using equipment provided to the Participant by Mana Skateboarding, either at this time or in the future, the Participant agrees:

That the Participant participates in activities provided by Mana Skateboarding at his/her own risk.

That the Participant agrees that in participating in a lesson/event/competition provided to him/her by Mana Skateboarding he/she totally releases from all liability whatsoever and indemnifies Mana Skateboarding and its employees and agents and contractors against any losses, damages, coasts, expenses, liabilities and judgments suffered or incurred by the Participant or any other person in respect of the said activities.

That Mana Skateboarding has no liability to the Participant for personal injury, disease or death arising from the services and/or equipment that Mana Skateboarding provides to the Participant.

That the Participant will comply promptly with all directions given to him/her by coaches and other officials of Mana Skateboarding, its employees, agents and contractors during any Mana Skateboarding lesson/event/competition.

Mana Skateboarding may take photos/videos during a Mana Skateboarding lesson/event/competition and Participants agree that photos/video taken at such times may be used for promotional or marketing purposes by Mana Skateboarding.
